# Miloš Milenković CURRICULUM VITAE

#### Outline

Miloš Milenković (Born in Belgrade, 1975), PhD Professor at the Department of Ethnology and Anthropology, Faculty of Philosophy, University of Belgrade.

Dr. Miloš Milenković is a distinguished academic figure renowned for his contributions to the fields of anthropology and ethnology, intangible cultural heritage and research evaluation and management. With a career spanning over two decades, Dr. Milenković has established himself as an authority in his domain. His academic portfolio is rich and diverse, including courses on anthropological research methods, anthropology of science and politics, anthropology of intangible cultural heritage, comparative anthropology, and the anthropology of the European Union, among others. Beyond his primary role, he has extended his expertise to students in various disciplines, such as demography, sports, physical education, psychology, mathematics, and history and philosophy of science, fostering a multidisciplinary approach to learning.

Dr. Milenković has led numerous research projects, both nationally and internationally. His work has not only enriched academia but also contributed to societal advancements. Dr. Milenković's research interests span both fundamental and applied aspects of anthropology. His fundamental pursuits encompass the history, theory, and methodology of anthropological research, the anthropology of science and education, multiculturalism, and identity politics. On the applied front, he delves into public policy, focusing on scientific, educational, and cultural aspects, evaluation and quality assurance in higher education and research, research ethics, cultural heritage protection, European studies, and sociocultural aspects of quality of life.

Over the years, Dr. Milenković has mentored numerous students, supervising dozens of diploma and Master's theses and guiding many PhD dissertation projects. He has also been involved in various regulatory and evaluation bodies, influencing academic policies and standards.

As an active participant in the academic community, Dr. Milenković held positions such as the Serbian member of the Management Committee of COST CA 15137 ENRESSH (European Network for Research Evaluation in the Social Sciences and Humanities) and the International representative of the Serbian Ethnological and Anthropological Association in the World Council of Anthropological Associations (WCAA). His contributions extend to being an expert-evaluator for Horizon 2020 for the Research Executive Agency of the European Commission.

Dr. Milenković's dedication to academia goes beyond his teaching and research. He has been at the forefront of various policy initiatives aimed at addressing discrimination and reforms in the higher education, research, and culture sectors. His advocacy for curricular reform under the banner of "Science with and for Society" exemplifies his commitment. He served at national Council for the Humanities and many other boards within higher education and research sectors. In recognition of his outstanding contributions, the Faculty of Philosophy, University of Belgrade, nominated Dr. Milenković for the position of Vice Rector for Research of the University of Belgrade in 2022.

As an OSI Civil Society Scholar, he conducted extensive comparative research on the omission of minority cultural heritage in post-Yugoslav states. The insights from this research are documented in an upcoming book by Routledge.

Dr. Milenković's recent work is characterized by a profound commitment to stakeholder inclusion, aligning with international knowledge-to-policy oriented approaches to peacekeeping, reconciliation, and the stabilization and development agenda for Southeastern Europe. He determinedly seeks ways to ensure that the social sciences and humanities remain relevant in contemporary times, even in an environment increasingly influenced by populism.
